Our longtime member, Marvene Wurst, passed away. Here is the obituary; the club is sending flowers.

Services were 11:00 am Thursday, February 8, 2018, at the Milford United Methodist Church with Pastor Lyle Schoen officiating. Visitation was Wednesday, from 10:00 am-8:00 pm at Lauber-Moore Funeral Home. The family received relatives and friends from 6-8:00 p.m. Wednesday at the funeral home. A private family burial will be at Salem Cemetery. Memorials have been established to the Milford Public Schools Foundation.

Marvene Marie Wurst was born November 12, 1935, in Lincoln, Nebraska to George and Evelyn (Brockway) Harrison, and passed away Saturday, February 3, 2018, at Crestview Care Center in Milford at the age of 82.

As a young girl, Marvene's family moved to Haddam, Kansas, later moving to Milford where she graduated from Milford Public School with the class of 1952. She furthered her education by attending Chadron State College. Marvene moved to Lincoln where she was employed with the University of Nebraska Ag College as secretary in the Poultry Improvement department. On May 22, 1955, Marvene was united in marriage to Howard Wurst in Milford and to this union three children were born, Wendy, Van and Lance. Together they lived in the Milford area their entire life. They farmed for 15 years east of Salem Church before moving into Milford where she was employed as the superintendent's assistant for over 30 years with the Milford School District. Marvene and Howard were life-time members of the Milford United Methodist Church. Marvene and Howard were involved in dog clubs in Seward, Lincoln and Omaha where they instructed dog obedience classes over the years. She was active with the local 4-H Clubs, the American Legion Auxiliary, was secretary for the Milford Chamber of Commerce, and was active with the Milford United Methodist Women and the local FoodNet .

Survivors include her husband, Howard; daughter, Wendy Dale, of Utica; sons and daughters-in-law, Van and Pam Wurst, Omaha, Lance and Paula Wurst, Grant; five grandchildren, Brent and Angel Dale, Utica, Rhett and Mary Wurst, Kasey Wurst, all of Omaha, Sarah and Nathan Holst, Duluth, MN, and JoAnna Wurst; Prescott, AZ, three great-grandchildren, Paul Dale, Henry and Mae Wurst; nieces, nephews, and a host of other relatives and friends.

Marvene was preceded in death by her parents, her brother, Richard in 2017, sisters-in-laws, Doris Heller, Lela Grimes, Edith Gloystein, and Carol Stauffer and a son-in-law, Arthur Dale.
